

Real estate pros reveal the hottest private pools up for grabs in NYC

Private pools are rare in the Big Apple, but they do exist. And just in time for summer, the folks at StreetEasy have identified nine sales listings in Manhattan that offer a chance for New Yorkers to take a dip in the confines of their private pool or hot tub.

These rare amenities can be found clustered below Houston Street, with one outlier in Chelsea and another on East 63rd Street on Lenox Hill.

The priciest pool-equipped offering on the list is the sevenbedroom townhouse at 116 Waverly Place. This newly-renovated, turn-of-the century mansion is listed for \$34 million.

The rooftop pool and hot tub were installed as part of the renovation and required steel reinforcements added to the walls, according to Jim St Andre of Peter McCuen & Associ-

ates, who is marketing the property. The pool and hot tub together take up almost all of the width of the 22-foot wide roof. The pool is not wide, but it has a resistance current – allowing for long-distance swimming without ever to leaving the roof or even turning around.

"It's great because people can enjoy relaxing in the pool recreationally, or they can turn on the current and train for a triathlon," St Andre said. "It's a great sort of multi-purpose pool.

He estimates the surrounding outdoor space provides room for entertaining a few dozen people. The roof offers protected views to the north and south, allowing pool-loungers to take in both the Empire State Building and the World Trade Center. "There's not another home in Manhattan that gets a better

view," St Andre said. Of course, the flip side of a view is that one is also on view.

Total privacy is hard to come by. But this location benefits from being in a low-built neighborhood, according to the broker.

"It is relatively private for a swimming pool that's on top of a six-story building in Manhattan," he said.

For those willing to forgo the sun and views in favor of

complete privacy, an indoor swimming pool is the way to go. And 232 East 63rd Street might be just what they're looking

This mansion was gut-renovated by the current owner, (reported to be Alex Rvot), and is listed for \$25 million with Tal Alexander, Oren Alexander and Sarah Williams of Douglas Elliman

The basement pool and jacuzzi sit in a mosaic-laden baseent, under ceilings that Alexander estimated measure 11 feet. The pool, he said, is approximately 50 feet long. There's

The seller renovated the property for his private use, a went to Italy to pick out the teal tiles and other materials in the pool as part of the renovation, Alexander said. "No investor

would have put this much money into a house." An option for the do-it-yourself water enthusiasts is 308 West 18th Street, listed for \$9.99 million. The "constructionready" property come with pre-approved plans for is a singlefamily residence with a rooftop pool. Daniel Hedaya and Tony Leondis of Platinum Properties

are in charge of the marketing. Construction cost are estimated between \$250 and \$350 per square foot for the 8,200 s/f plans, according to Hedaya.

Not all rooftop soaking spots are in single-family homes, but adding them to a shared building can take a little negotiation with neighbors.


The sellers of the penthouse at 51 Walker Street, listed for \$7.75 million, bought the apartment pre-constriction and arranged for an outdoor eight-person hot tub and planters to provide a natural visual screen, according to Brad Randall, an agent with Halstead.

The condo board required a special report from a structural engineer before it was approved, he said. "I remember when they were doing this, it was quite a hassle. It was a number of weeks.

Now, however, the a owner has the opportunity to enjoy the bub-bling water hassle-free. "It has all it's credentials, so

Buyers rarely come through look-

ing for a rooftop hot tub, he said, but "I've found that most people have been pleasantly surprised... especially if they come at night and see the view."

Randall is marketing the apartment with Francine Port. also of Halstead.

A few other pool listings include the penthouse at 55 Warren Street in Tribeca, which has a resistance pool on the roof, and is listed for \$16 million.

One \$14.9 million unit at 459 West Broadway has a "foot pool" and an outdoor shower. For hot tubs, check out the penthouses at 115 Allen, listed for \$4.4 million, and 481 Greenwich Street, listed for \$8.99 million.
